#### Doctor of Philosophy (PhD)

The Doctor of Philosophy degree is awarded by MCW in recognition of marked ability and achievement in a particular field of biomedical science or public and community health. To earn the PhD degree, a student must submit a dissertation representing an original research contribution and complete a public defense of that dissertation

#### Doctor of Public Health (DrPH)

The Doctor of Public Health degree is a professional doctoral degree awarded by MCW in recognition of expertise in evidence-based public health practice and research. Students participate in a three-year curriculum that includes coursework, an applied practice experience, and a dissertation. Candidates for the DrPH degree must complete a dissertation that generates a field-based product consistent with advanced practice designed to influence programs, policies or systems addressing public health.

#### Master of Science (MS)

The Master of Science degree is awarded at MCW for postgraduate study in a specific field of biomedical or translational science. A master's thesis that gives evidence of marked scholarly attainment in the student's major subject is required. Candidates for the MS degree must either complete a public defense of their thesis or pass a comprehensive examination based on their total graduate program.

#### Master of Arts (MA)

The Master of Arts degree is awarded at MCW in the field of bioethics. A comprehensive examination is required following completion of core coursework. Students may

choose between a thesis option and a non-thesis option. A master's thesis providing evidence of high scholarly achievement in the student's area of study must also undergo a public defense. The non-thesis option requires a final paper of publishable quality followed by an oral public defense. The MA program accommodates accelerated or part-time schedules. All degree requirements must be completed within four years, but the average is two years.

#### Master of Medical Physiology (MMP)

The Master of Medical Physiology degree is awarded at MCW for completion of a one-year program that is closely integrated with the first-year medical student curriculum at MCW. The program provides an experience comparable to that of a medical student, including examinations. It is designed to give students a deeper understanding of human physiology and for college graduates looking to strengthen their academic credentials in preparation for applying to US medical schools

#### Master of Public Health (MPH)

The Master of Public Health degree is awarded by MCW for completing curricula focused on public health practice. The online program allows students to learn and apply evidence-based strategies for prevention and community health improvement initiatives. The program takes a broad approach to public health and graduates are prepared to work in leadership positions in a variety of settings such as governmental agencies, non-profit organizations, healthcare systems, community-based organizations. academic institutions, and other industries. Candidates for the MPH degree complete an applied practice experience and capstone project as culminating experiences to demonstrate mastery of public health competencies.

### Degrees Awarded

#### Doctor of Pharmacy (PharmD)

The Doctor of Pharmacy degree attests to general knowledge in all fields of pharmacy. The degree is awarded at MCW for completion of the accelerated, three-year program comprised of comprehensive didactic education, robust skills development, and extensive clinical training related to pharmacy practice. The PharmD degree offers opportunities in clinical practice, research, teaching, pharmaceutical industry, manufacturing, judicial, and a multitude of other areas. Successful passing of the North American Pharmacist Licensure Examination, Multistate Pharmacy Jurisprudence Examination, and other state specific requirements are necessary for practice as a registered pharmacist.

#### Doctor of Medicine (MD)

The Doctor of Medicine degree attests to general knowledge in all fields of medicine as well as the foundational skills required for the practice of medicine. An MCW graduate is prepared to demonstrate problemsolving skills, knowledge of normal and abnormal states, the ability to acquire and utilize information in the clinical management of patients, and the empathic values and caring attitudes critical to the practice of medicine. All medical students are required to take and pass the United States Medical Licensing Examination Step 1 and Step 2- Clinical Knowledge, which are administered by the National Board of Medical Examiners

### Leadership



President Chief Executive Officer

John R. Raymond, Sr., MD, joined the Medical College of Wisconsin as its sixth President and CEO in July 2010. He previously served as Vice President for Academic Affairs and Provost at the Medical University of South Carolina (MUSC), where he had been a faculty member since 1996.

Dr. Raymond leads Wisconsin's only private health sciences university, which includes the nation's third-largest private medical school. Under his leadership, MCW continues to be a leader of innovation as Wisconsin's largest private research institution.

A practicing nephrologist with active roles in clinical care, teaching and faculty mentorship, Dr. Raymond also is a medical researcher studying the basic mechanisms of kidney cell function. He has published more than 140 full-length manuscripts and earned nearly \$40 million in funding in his career. He is a member of the Association of American Physicians and the American Society for Clinical Investigation.

Dr. Raymond is a member of the Board of Directors of the United Way of Greater Milwaukee and Waukesha County and served as Co-chair of the 2020 United Way Campaign. He also serves on the Board of Directors of the Versiti Blood Center of Wisconsin's Blood Research Institute. Dr. Raymond is the Past President of the Board of the American Heart Association of Metro Milwaukee. He recently was named as a 2024 Wisconsin Titan 100, which recognizes the state's most accomplished business leaders in their respective industries.



#### Provost and Executive Vice President The Julia A. Uihlein, MA, Dean of the School of Medicine

Joseph E. Kerschner, MD, became Dean of the School of Medicine and Executive Vice President of the Medical College of Wisconsin in November 2011. Dr. Kerschner assumed the additional role of Provost in June 2017. In late 2020, Dr. Kerschner was named the inaugural Julia A. Uihlein, MA, Dean of the School of Medicine. He also is a Professor in the Departments of Otolaryngology and Communication Sciences, and Microbiology & Immunology. Dr. Kerschner's past executive positions include CEO of Children's Specialty Group and Executive Vice President of Children's Wisconsin

An alumnus of MCW, Dr. Kerschner joined the faculty in 1998. As a physician at Children's Wisconsin, his clinical focus is on otitis media (ear infections), voice disorders and vascular anomalies in children. Dr. Kerschner's research includes studies to identify causes of and potential new treatments for pediatric ear infections. Dr. Kerschner has published more than 170 articles, book chapters and reviews in professional journals, and has presented extensively on his clinical and research areas of expertise at scientific meetings.

In November 2020, Dr. Kerschner completed his one-year tenure as Chair of the Board of Directors for the Association of American Medical Colleges (AAMC), an organization that represents more than 170 medical schools in the United States and Canada. He also previously served as Chair of the AAMC's Council of Deans.



Executive Vice President for Finance and Administration Chief Operating Officer

Matthew Lester, MBA, MHA, CPA, was appointed as Executive Vice President for Finance and Administration, and Chief Operating Officer, effective August 1, 2022. He serves as the principal administrative officer of the Medical College of Wisconsin and is a member of the institution's leadership team.

Mr. Lester is responsible for MCW's financial functions as well as the planning, organizing, evaluating and monitoring of all administrative and facilities functions. He oversees strategic financial and administrative planning, budget development and implementation, policy formulation, facilities and organizational development. Additionally, he has oversight of facilities, central purchasing, information services and other institutional functions as required to support MCW's missions.

Mr. Lester possess more than 25 years of management experience leading and advising healthcare and higher-education organizations. He is a highly collaborative executive, combining strategic planning, operational acumen and business development expertise to develop actionable solutions for a broad array of challenges. Additionally, he brings a robust background of management consulting and financial leadership at two medical schools and experience working closely with hospital leadership to design and execute an aligned affiliation and joint strategy.



Senior Associate Dean for Education, School of Medicine

José Franco, MD, Professor of Medicine (Gastroenterology and Hepatology), was named Senior Associate Dean for Education in the School of Medicine in April 2022. He previously served as Interim Senior Associate Dean for Academic Affairs in the School of Medicine from April 2021 through April 2022. He also serves as Associate Dean for Educational Improvement and as Standardized Teaching and Assessment Resource (STAR) Center Director.

Dr. Franco's extensive service to the education mission also includes his past role as Discovery Curriculum Director.

Dr. Franco has witnessed and/ or been involved in curriculum reform, innovation and excellence in teaching at MCW for more than 30 years. Dr. Franco is a member of MCW's Society of Teaching Scholars and received the institution's Distinguished Service Award in 2013.



Founding Dean, Medical College of Wisconsin-Green Bay

Matthew L. Hunsaker, MD, joined the Medical College of Wisconsin as the Founding Campus Dean for the Medical College of Wisconsin-Green Bay and Professor of Family and Community Medicine in January 2014.

Dr. Hunsaker provides overall leadership and management of MCW's regional medical school campus in Green Bay and serves as the primary liaison for our health system, academic and community partners in Northeast Wisconsin, as well as with MCW's Milwaukee campus. Dr. Hunsaker continues to serve as a national and international resource for medical education, Human Resources in Health (HRH), particularly in the design and scale-up of medical education, primary care, and communitybased medical teaching models.



#### Sentry Dean and Founding Dean, Medical College of Wisconsin-Central Wisconsin

Lisa Grill Dodson, MD, Professor of Family and Community Medicine, joined the Medical College of Wisconsin as Founding Dean for the Medical College of Wisconsin-Central Wisconsin in August 2014. She was named the Sentry Dean, MCW-Central Wisconsin, in December 2019. Dr. Dodson provides overall leadership and management of MCW's regional medical school campus in Central Wisconsin and serves as the primary liaison for our health system, academic and community partners in that locale, as well as with MCW's Milwaukee campus.

Prior to joining the MCW faculty, Dr. Dodson was Director of the Oregon Area Health Education Center and Associate Professor of Family Medicine at Oregon Health & Science University in Portland.

Dr. Dodson advocates for innovation in both medical education and care delivery to ensure the availability of high-quality care to rural and other non-urban populations. Her leadership has been recognized by the receipt of several awards, including the Oregon Family Physician of the Year in 2009 and the MCW President's Community Engagement Award in 2017.

#### Founding Dean, School of Pharmacy

George E. MacKinnon III, PhD, MS, RPh, joined the Medical College of Wisconsin in 2015 as Founding Dean and Professor of the School of Pharmacy. He also serves as Professor of Family and Community Medicine in the School of Medicine and Institute for Health & Equity in the Graduate School.

He leads the MCW School of Pharmacy to deliver a dynamic and innovative Doctor of Pharmacy curriculum and to expand pharmacist care models in collaborative approaches to teambased care. Dr. MacKinnon has held academic appointments in medicine and pharmacy engaging in clinical practice, research, teaching, and academic administration, where he has helped to successfully establish four new academic pharmacy programs across the United States. His non-academic appointments have included Vice President of Academic Affairs with the American Association of Colleges of Pharmacy, and Director of Global Health Economics & Outcomes Research at Abbott Laboratories. He is a Fellow of the American Society of Health-System Pharmacists (FASHP) and Distinguished Scholar Fellow of the National Academies of Practice (NAP). He is a recipient of an honorary Doctor of Medical Sciences from the Medical College of Wisconsin in 2022. Dr. MacKinnon serves on the board of the Pharmacy Society of Wisconsin and AACP as Chair-elect representative of the Council of Deans (COD).



#### Dean, School of Graduate Studies

Daisy Sahoo, PhD, was named Dean of the Medical College of Wisconsin School of Graduate Studies and the inaugural holder of the Women in Science Endowed Professorship effective February 1, 2024. She also currently serves as Professor of Medicine, with secondary appointments in the Departments of Biochemistry and Pharmacology & Toxicology. As Dean, she oversees all aspects of the MCW Graduate School, which includes 33 different academic programs comprising doctorate, Master's, and certificate programs.

Dr. Sahoo joined the MCW faculty in 2007 as Assistant Professor of Medicine and rose through the ranks to Professor with Tenure in 2018. She served as Vice Chair for Research in the Department of Medicine from 2014–2024 and as President of the MCW Faculty Council from 2020–2021.

Dr. Sahoo's work has been supported by the NIH with continuous R01 funding since 2007, and she has directly generated more than \$7.1 million in total research funding to study cholesterol transport and cardiovascular disease. She received MCW's *Women in Science Pioneer Research Award* in 2021.

Dr. Sahoo has mentored numerous undergraduate, medical and graduate students as well as postdoctoral fellows and faculty. Her mentoring efforts were recognized with the Department of Medicine's *Mentorship Award*, by MCW's graduate students with the 2023 *Mentor of the Year* award, and at the national level with a mentoring award from the American Heart Association.

### Dalvery Blackwell

Doctor of Humanities



For the last 15 years, Ms. Dalvery Blackwell has served as a Co-Founder and Executive Director of the African American Breastfeeding Network (AABN). Her career is dedicated to improving maternal-child health outcomes, championing breastfeeding equity by advocating for system/ policy changes, and partnering with communitybased, family-centered, culturally tailored health education and support services. Before founding AABN, she worked in different capacities in public health. As a program coordinator for the Black Health Coalition of Wisconsin, Ms. Blackwell was instrumental in leading the efforts to make Wisconsin one of the first states in the country to create legislation banning smoking in public places. Soon after marrying and having her first child, Ms. Blackwell committed her work to addressing breastfeeding disparities. Her first stop on her public health journey was a job with the Milwaukee County's Special Supplemental Nutrition Program for Women, Infants, and Children as a breastfeeding peer counselor. Soon after, in 2011, she became an International Board-Certified Lactation Consultant.

Under Ms. Blackwell's direction, AABN has worked to enhance and improve maternal and infant health by providing breastfeeding education, support, and services, especially for families at risk for prematurity and adverse birth outcomes. AABN was created to normalize breastfeeding by eradicating stigma, providing support, and increasing selfefficacy and knowledge of breastfeeding rights in public, professional, and educational settings. Culturally relevant programming from AABN begins with prenatal education and support and extends through the postpartum period for the entire family. In 2019, the Board of Directors led the mission change to include advocating for breastfeeding equity and championing maternal-child health.

The many accomplishments of AABN as a reproductive justice community-based organization has enabled it to receive consistent funding from local and national foundations, donors, organizations, and government sources. In 2020 and 2021, AABN received \$500,000 in funding to form the WeRISE Doula program, intended to provide labor and delivery support and protection from COVID-19 to Black birthing families in southeastern Wisconsin. In 2022, AABN received another \$500,000 grant from the Wisconsin Department of Health Services, which brought the nationally acclaimed, evidence-based, traumainformed care doula training from HealthConnect One to the WeRISE Doula Initiative. In 2023, Ms. Blackwell joined Drs. Anna Palatnik (Contact PI), Jessica Olson, Joni Williams, and Julia Dickson-Gomez (MPIs) as a Co-Investigator on the ASCEND Wisconsin Initiative, a seven-year, \$10 million NIH-funded proposal which aims to eliminate racial and ethnic disparities in maternal morbidity in southeastern Wisconsin through equitable partnerships and commitment to policy-level change.

Through Ms. Blackwell's leadership and vision. AABN has built eminent goodwill in the community. The organization has been recognized and highlighted in local, state, and national media, including Essence Magazine's "Top Ten Things People Are Talking About," and the CDC "Breastfeeding Report Card." Ms. Blackwell is a recipient of the Wisconsin Public Health Association's Award for Excellence in Health Promotion and Disease Prevention, the Wisconsin Alliance for Women's Health's Women of Commitment Award, and the Milwaukee Community Journal's Year of the Child: A Game Changer Honoree.

### David C. Leach, MD **Doctor of Medical Science**



David C. Leach, MD, was born in Elmira, New York. He received his undergraduate degree from St. Michael's College of the University of Toronto, his medical degree from the University of Rochester School of Medicine and Dentistry, and his training in Internal Medicine and Endocrinology and Metabolism at the Henry Ford Hospital in Detroit. He received additional training in Pediatric Endocrinology at the Children's Hospital of Pittsburgh in Pittsburgh, Pennsylvania.

For nearly thirty years. Dr. Leach practiced endocrinology at Henry Ford Hospital, taught the Picker Institute; the Rosalind Franklin University of Michigan medical students, and was a teaching hospitalist. In the early 1980s he became the Director of Medical Education and Transitional Residency program director at Henry (AAMC) Award for Excellence in Medical Ford. He also became seriously interested in how resident physicians acquire competence, and in 1997 was recruited to lead the Accreditation Council for Graduate Medical Education clinic in downtown Detroit. At that time, the Dr. Leach now lives in Williamsburg, Virginia, ACGME accredited more than 6,000 residency with Jackie, his wife of almost fifty years, and programs in 120 different specialties that in spends his time noticing beauty, practicing aggregate housed more than 110,000 residents. gratitude, and embracing patience. In 2007, he received the Association of American Medical Colleges' Education (formerly called the Flexner Award). He also was given the Good Samaritan Award by Michigan's Governor John Engler for 25 years of volunteer service at the Cabrini Clinic, a free

#### Amy Lovell Doctor of Humanities



A passionate service-driven leader who is committed to creating and supporting a trauma-responsive community, Ms. Amy Lovell co-founded two of southeastern Wisconsin's preeminent organizations that address mental health and wellness.

Ms. Lovell co-founded REDgen (Resilience EDucation for a new generation), a nonprofit organization that works to bridge systems to promote resiliency in the lives of our youth and families. She currently serves on the organization's board of directors.

REDgen is a peer-to-peer resiliency program that builds a foundation for all youth to move from surviving to thriving at school, home, and within their communities. There are approximately 30 REDgen chapters in participating middle and high schools in the greater Milwaukee area. The program has developed more than 400 student leaders and impacted more than 17,000 youth.

Ms. Lovell also co-founded Scaling Wellness in Milwaukee (SWIM) with her husband, Marquette University President, Dr. Michael R. Lovell. SWIM is an organization that drives community-based collaboration to help prevent and respond to trauma and create a resilient Milwaukee. Through education, training, and wellness and resilience services, the organization equips community members with the tools they need to understand their own trauma, heal, and build resilience.

SWIM programs provide wellness and resilience services and teach SWIM's workplace training program, which helps organizations build awareness of the role of trauma in the workplace and develop policies and procedures that respond to trauma.

In recognition of the Lovells' tremendous leadership to address mental health at Marquette and across Milwaukee and the region, the third and fourth floors of the wellness tower within the Marquette University's new Wellness + Helfaer Recreation facility will be named the Lovell Center for Student Well-Being. The Lovells were named the 2018 Community Leaders of the Year by BizTimes Milwaukee for their commitment to building a healthier, more productive Milwaukee.

In 2020, Ms. Lovell was honored by the *Milwaukee Business Journal* as a Woman of Influence.

She earned a Bachelor of Science degree in pharmacy from the University of Pittsburgh and worked as a licensed pharmacist in New York, Kentucky, and Pennsylvania prior to moving to Milwaukee in 2008. She and Dr. Lovell are the parents of four adult children.

### Michael Lovell Doctor of Humanities



Dr. Michael R. Lovell was named Marquette University's 24th President in March 2014. Under his visionary leadership, Marquette focuses on innovation, entrepreneurship, and community renewal and development — all consistent with the university's Catholic, Jesuit mission. Since being diagnosed with sarcoma in August 2021, Dr. Lovell has been very active in raising funds for cancer research and support programs. He presently serves as the Co-chair of the Wisconsin chapter of CEOs Against Cancer, a program of the American Cancer Society. The Lovells co-chaired the 2023 Stronger than

Sarcoma Soiree for Research. Dr. Lovell was featured in the October 2023 Rare Storytellers program presented by Harmony 4 Hope in partnership with the Linda T. and John A. Mellowes Center for Genomic Sciences and Precision Medicine at the Medical College of Wisconsin.

 The fourth-longest serving president in Marquette's 143-year history, Dr. Lovell serves on the boards of The Water Council; the Association of Jesuit Colleges and Universities; the Wisconsin Association of Independent Colleges and Universities; and the Fund for

Catherine R. Lucey, MD, MACP, leads the robust research enterprise and highly ranked academic

programs at the University of California, San Francisco (UCSF), as Executive Vice Chancellor and Provost.

Dr. Lucey works in close collaboration with the Chancellor and the leadership team to develop and implement campus priorities and vision, maintain the University's status as an international leader in health sciences education and research, and oversee external partnerships representing UCSF's best interests across the University of California system, at the UC Office of the President, and beyond.

Renowned for her leadership, Dr. Lucey was Vice Dean for Education and Executive Vice Dean for the School of Medicine, reporting to Dean Talmadge E. A champion of diversity, equity, and inclusion, Dr. Lucey also was on the executive management team for the School of Medicine's Differences Matters Initiative and oversaw other strategic projects across the campus. Her national portfolio of work has included membership on the National Academy of Medicine, the Board of Directors of the Association of American Medical Colleges, and the American Board of Medical Specialties.
