During the event, panelists discussed the role that academic medicine plays in the ongoing climate crisis, both as contributors to the problem by participating in high carbon emitting procedures and research, but also as part of the solution, by engaging students, clinicians, researchers, and the communities they serve to work across disciplines and effect change. Panelists agreed that, while the crisis can leave many feeling lost and without agency, we should “never worry alone.” Several discussed their advocacy efforts at their respective institutions to incorporate climate content throughout the medical school curricula. Closing questions from the audience touched on topics including sustainable changes to medical school curricula, competitiveness as a driver of change, and impacts of the pandemic on stakeholder buy-in.
