Leadership

President Chief Executive Officer

John R. Raymond, Sr., MD, joined the Medical College of Wisconsin as its sixth President and CEO in July 2010. He previously served as Vice President for Academic Affairs and Provost at the Medical University of South Carolina (MUSC), where he had been a faculty member since 1996.


Dr. Raymond leads Wisconsin's only private health sciences university, which includes the nation's third-largest private medical school. Under his leadership, MCW continues to be a leader of innovation as Wisconsin's largest private research institution.

A practicing nephrologist with active roles in clinical care, teaching and faculty mentorship, Dr. Raymond also is a medical researcher studying the basic mechanisms of kidney cell function. He has published more than 140 full-length manuscripts and earned nearly \$40 million in funding in his career. He is a member of the Association of American Physicians and the American Society for Clinical Investigation.

Dr. Raymond is a member of the Board of Directors of the United Way of Greater Milwaukee and Waukesha County and served as Co-chair of the 2020 United Way Campaign. He also serves on the Board of Directors of the Versiti Blood Center of Wisconsin's Blood Research Institute. Dr. Raymond is the Past President of the Board of the American Heart Association of Metro Milwaukee. He recently was named as a 2024 Wisconsin Titan 100, which recognizes the state's most accomplished business leaders in their respective industries.

Interim Provost

Cheryl A. Maurana, PhD, is the Interim Provost, Stephen and Shelagh Roell Endowed Chair, Professor of Bioethics and Medical Humanities, Founding Director of the Kern National Network for Flourishing in Medicine, and Senior Vice President for Strategic Academic Partnerships. In her role as Interim Provost – which she assumed on January 1, 2025 – Dr.



Interim Dean, School of Medicine

Deborah M. Costakos, MD, MS, assumed the position of Interim Dean of the School of Medicine on January 1, 2025. She also serves as Professor of Ophthalmology and Visual Sciences and was the Chair of that Department from January 1, 2020, to December 31, 2024, following 11 months in the Interim Chair role. As Interim Dean of the School of Medicine (SOM), Dr.



Costakos is responsible for the conduct and advancement of the programs of the SOM; maintaining the highest standards of excellence in the academic affairs of the SOM; fostering competitive biomedical research programs; and ensuring high-quality patient care and engagement of communities to advance health for all. Dr. Costakos serves as the chief administrative and academic officer of the SOM and oversees the Liaison Committee on Medical Education (LCME) accreditation. She recommends primary or secondary faculty appointments for individuals requesting appointments in the SOM and recommends appointments and reappointments to a named or endowed chair/professorship. Additionally, Dr. Costakos oversees MCW's Senior Associate Deans. Clinical and Basic Science Department Chairs, Institute and Center Directors, and the Deans of MCW's regional campuses in Central Wisconsin and Green Bay. Dr. Costakos received her MD from MCW in 1998. Following completion of her ophthalmology residency and fellowship in pediatric ophthalmology, she entered private practice. Since joining MCW in 2009, Dr. Costakos has developed a nationally recognized program for the care of infants with Retinopathy of Prematurity, started a pediatric ophthalmology fellowship, and prior to taking the chair role, served as Medical Director for Pediatric Ophthalmology.

Leadership

Sentry Dean and Founding Dean, Medical College of Wisconsin-Central Wisconsin

Lisa Grill Dodson, MD, Professor of Family and Community Medicine, joined the Medical College of Wisconsin as Founding Dean for the Medical College of Wisconsin-Central Wisconsin in August 2014. She was named the Sentry Dean, MCW-Central

Wisconsin, in December 2019. Dr. Dodson provides overall leadership and management of MCW's regional medical school campus in Central Wisconsin and serves as the primary liaison for our health system, academic and community partners in that locale, as well as with MCW's Milwaukee campus.

Dr. Dodson advocates for innovation in both medical education and care delivery to ensure the availability of high-quality care to rural and other non-urban populations. Her leadership has been recognized by the receipt of several awards, including the *Oregon Family Physician of the Year* in 2009 and the MCW President's *Community Engagement Award* in 2017.



Assistant Dean, Basic Sciences, Medical College of Wisconsin-Central Wisconsin

Roy M. Long, PhD, is the Assistant Dean for Basic Sciences and an Associate Professor of Microbiology and Immunology. He received his bachelor and graduate degrees from the Pennsylvania State University and completed his post-doctoral

work at the University of Massachusetts Medical School and the Albert Einstein College of Medicine. Upon arriving at the Medical College of Wisconsin, he was named a Pew Biomedical Scholar for his research related to the spatial regulation of gene expression in the yeast S. cerevisiae. He previously served as a course director in both the Medical and Graduate Schools and currently is an instructor in the Medical School, where his teaching has been recognized by his election into the Medical College of Wisconsin Society of Teaching Scholars. Dr. Long served on the admissions committee for both the Medical and Graduate Schools, and he was formerly the Assistant Dean for Recruitment and Admissions. He received Medical College of Wisconsin Faculty Service Awards for his work on the Medical School Admissions and Academic Standing Committees. Dr. Long is a member of the American Association for the Advancement of Science and the International Association of Medical Science Educators.

Jacob P. Prunuske, MD, MSPH, is an Associate Professor of Family and Community Medicine and the Assistant Dean for Clinical Learning at the Medical College of WisconsinCentral Wisconsin campus.



He learned his bachelor and medical degrees at the University of Wisconsin. He completed his Family Medicine Residency and Master of Science in Public Health at the University of Utah. His research has focused on family medicine and public health education. Chair of the Board:

Elizabeth "Betsy" Brenner is an active volunteer in the Milwaukee community. Along with her service as a Medical College of Wisconsin trustee and member of its executive committee, she sits on the executive committees of the Greater Milwaukee Committee, and has held leadership roles in Planned Parenthood of Wisconsin, The Boys & Girls Club and Milwaukee Film.

Ms. Brenner stepped down in 2016 after more than three decades in the newspaper industry. She was named Publisher and President of the *Milwaukee Journal Sentinel* in January 2005, and also served as Executive Vice President of Journal Communications and its spinoff company, Journal Media Group. During her tenure at Wisconsin's largest newspaper, the *Milwaukee Journal Sentinel* won three Pulitzer Prizes, including one awarded in 2011 that told the story of groundbreaking genomic research conducted at the Medical College of Wisconsin.

Prior to coming to Milwaukee, Ms. Brenner was President and Publisher of *The News Tribune* in Tacoma, WA and *The SUN* in Bremerton, WA. She had earlier leadership responsibilities at the *Denver Rocky Mountain News*, *The Miami Herald* and *The New York Times*. She began her career as a business news reporter at *The Chicago Tribune*.

Ms. Brenner attended Northwestern University in Evanston, Ill., where she received a Bachelor of Science degree in journalism in 1976 and Master of Business Administration degree in 1978.

Jesse M. Ehrenfeld, MD, MPH, FAMIA, FASA

Jesse M. Ehrenfeld, MD, MPH, FAMIA, FASA, serves as Director of the Advancing a Healthier Wisconsin Endowment (AHW) and Senior Associate Dean and Professor at the MCW School of Medicine. He divides his time among clinical practice, research, and directing the strategic and operational advancement of AHW, a statewide philanthropy established by MCW to serve as a resource to health research, education, and community initiatives across Wisconsin.

Under Dr. Ehrenfeld's leadership, AHW has awarded an average of \$16 million in grant awards annually into community and research initiatives aimed at improving health and advancing health equity in Wisconsin. In 2020, he led the coordination of AHW's rapid response to the COVID-19 pandemic, deploying more than \$4.8 million in grants to partners across the state. He was named by Managed Healthcare Executive Magazine as one of its 10 Emerging Industry Leaders.
