"Analyzing Collaboration and Partnerships for Affordable Housing in South Carolina: A Public Health Perspective"

Affordable housing is a critical issue in South Carolina, affecting the lives of many individuals and families. To delve deeper into this pressing concern, this study adopts a phenomenological approach to explore the lived experiences and perceptions of stakeholders involved in affordable housing initiatives across the state. Through in-depth interviews with key participants, including policymakers, nonprofit leaders, and community organizers, the research seeks to uncover the intricate dynamics of collaboration and partnership in addressing housing disparities and promoting housing equity. Drawing on the rich narratives and insights participants share, the study sheds light on the multifaceted challenges low-income individuals and families face in accessing affordable housing. It examines the strategies and approaches employed by local governments, community organizations, and advocates to address these challenges and foster more inclusive and equitable housing solutions.

Central to the study is the exploration of multi-sectoral collaborations and partnerships, which are pivotal in tackling complex social issues like affordable housing. The research highlights the importance of coordinated action and collective efforts in addressing marginalized communities' diverse needs and priorities by analyzing stakeholder interactions and relationships. Furthermore, the study emphasizes the critical role of community engagement and resident involvement in shaping affordable housing initiatives. Through meaningful participation in decision-making processes, community members can contribute valuable insights and perspectives, ensuring that affordable housing programs are tailored to meet the specific needs of local populations.
