ABOUT THE MCW SCHOOL OF PHARMACY

The Medical College of Wisconsin (MCW) School of Pharmacy is the only pharmacy school in Wisconsin to offer a three-year accelerated Doctor of Pharmacy (PharmD) program at a premier academic medical center.

PharmD students have access to clinical rotations and research experiences at some of the top facilities in the country. The School shares a campus with partners Froedtert Hospital (Level I Trauma Center) and Children's Wisconsin (Level I Pediatric Trauma Center). The Clement J. Zablocki VA Medical Center is another partner located just a short drive from campus.

The MCW PharmD program was granted full accreditation by the Accreditation Council for Pharmacy Education (ACPE) in January 2021 after graduating its first cohort in May 2020. Upon receiving full accreditation status, the MCW School of Pharmacy has demonstrated, to the satisfaction of ACPE, that its PharmD program complies with stringent accreditation standards.


MESSAGE FROM **OUR FOUNDING DEAN**

CLASS OF 2025 STATS

In mid-May, the MCW School of Pharmacy conferred the Doctor of Pharmacy (PharmD) degree on 41 students in the Class of 2025. Most graduates are continuing their education through residencies and fellowships.

90%

Postgraduate Year 1 (PGY1) Residency Match Rate

Following the American Society of Health-System Pharmacists Match, 26 of 29 participating students obtained postgraduate year-one (PGY1) positions, yielding a 90% PGY1 residency match rate – exceeding the national match rate of 81%. Overall, 85% of these graduates are continuing their training in Wisconsin.



FELLOWSHIPS

Three additional students secured post-doctoral positions in the pharmaceutical industry, for an overall post-graduate training match rate of 91%.

DIRECT-TO-CAREER PATH

One-third of 2025 graduates have chosen the direct-to-career pathway, securing or seeking employment in community pharmacy positions.

LEARN

Experiential Education

The MCW School of Pharmacy's Office of Experiential Education (OEE) meets individually with each pharmacy student several times throughout the three-year PharmD program. Faculty and staff dedicate time to understanding each student's personal career goals and how those goals may evolve as students gain experience working in different practice settings during weekly clinical rotations in their first two years of the program.

PharmD students now have the opportunity to build their professional networks and gain experience working in practice sites beyond the Milwaukee area. In fall 2024, MCW launched the Advanced Pharmacy Practice Experience (APPE) Rural Health Track, which enables pharmacy students during the third (and final) year of the curriculum to complete all seven of their six-week APPE rotations at rural sites in central or northeast

Also established in fall 2024, students interested in reducing global health inequities can complete an international APPE in partnership with Refuge International, which organizes medical volunteer trips in Guatemala.

Utilizing the AMA e-Learning Blood Pressure Module

The MCW School of Pharmacy is one of the first pharmacy schools in the country to incorporate the American Medical Association's blood pressure measurement e-learning series into its curriculum.

As the role of the pharmacist has evolved, it has become essential for Doctor of Pharmacy students to be properly trained in blood pressure measurement. Pharmacists can assist with hypertension management and addressing medication nonadherence that can make blood pressure difficult to control.

Spectrum News 1 Story: MCW PharmD Students Learn About Pharmacogenomics

Sage Orlowski, PharmD ('25) was featured in a Spectrum News 1 story on how MCW PharmD students learn about pharmacogenomics — the study of how a patient's genetic information influences their body's metabolization of drugs.

MCW students have the opportunity to test their own DNA sample through a partnership with RPRD Diagnostics. Sage also completed a clinical rotation at the RPRD lab.

Preparing Students for Pharmaceutical Industry Careers

Opportunities for pharmacy students to build skills in the pharmaceutical industry can be hard to come by, especially in Wisconsin, as most pharmaceutical companies are headquartered in the Northeast region. MCW PharmD students who want to pursue industry must be driven, working to build their CV by conducting research, writing papers and seeking out experiential education opportunities (often called "rotations").

They also work closely with MCW professors who have connections in the industry and can help build the student's professional network.

Dr. Abhay Chauhan is one of the pioneers of dendrimers for drug delivery applications and has created a cosmetic anti-aging cream called Amruth. Dr. Kristin Busse has contacts at NIH and FDA through her fellowship training at NIH's Clinical Center and NIAID.

In MCW's Class of 2025, three pharmacy students have accepted postdoctoral positions in the pharmaceutical industry.

Proposed Legislation

LRB-2415 Eliminate the Pharmacy Jurisprudence Examination (MPJE) Requirement: The Pharmacy Society of Wisconsin recommends eliminating the required law exam to become a licensed pharmacist due to the barrier it creates.

AB 43 / SB 42 Expanding Access to Contraceptives: This legislation would expand access to oral and patch contraceptives by allowing pharmacists to independently prescribe these products.

MCW Advocacy Day

During an on-campus Advocacy Day in March 2025, MCW pharmacy students learned about proposed pharmacy-related legislation and gained advice on lobbying best practices.

MCW's Office of Government Relations led a presentation including tips on persuasively presenting your case, using data to support your argument, how to make a request to legislators and how to follow up in a scenario where you are unable to answer a lawmaker's question.

Rachael Savage, PharmD Class of 2021




