residencies and professional certifications.

The 1-year full-time residency, beginning on July 1, is based at the MCW School of Pharmacy with a clinical practice site at Sixteenth Street Community Health Center and altScripts Specialty Pharmacy.

Building a Healthy Community

Sixteenth Street Community Health Centers (SSCHC) distinguishes our care with the deep understanding of social determinants of health and the years of development of programming to address these factors. We meet people where they are through proactive social services screening in our clinics, specialized diabetes and asthma programming, obesity intervention and prevention, and environmental programming to create resident-directed impact. Through full-service bilingual clinics, a behavioral health clinic, a satellite geriatric clinic, and six in-school clinics, Sixteenth Street cares for nearly 43,000 primarily low-income, Latinx or diverse individuals each year.

The clinical pharmacy team at SSCHC works closely with the caregivers throughout the organization. Clinical pharmacy services include patient visits under collaborative practice agreements, Medicare Annual Wellness Visits, medication reconciliations, managing our 340B drug pricing program formulary, and being a resource to our clinic staff for any and all clinical pharmacy questions or concerns.

The altScripts Specialty Pharmacy team offers a patient-centered care model.

Time will be split between the MCW campus and the Sixteenth Street Community Health Center and altScripts Specialty Pharmacy practice sites. SSCHC and altScripts are located a short 10-minute drive between each campus.

 Full-time role with expectations for 80% coverage at the clinical practice sites (2 days at SSCHC and 2 days at altScripts) and 20% coverage at MCW School of Pharmacy (equivalent of 1 day). Flexibility required as necessary to accommodate business needs.
