



# **Q&A** with the Chairman

# If our intention is to expand the number of providers/surgeon, how do we plan for more clinic and OR space?

This is a timely question. The system (and ortho) is growing at a rate of roughly 4-5% yearly and if this continues as we hope, additional volumes will be an issue. Froedtert recently hired a consultant to evaluate the procedural space needs over the next 10 years. They performed a detailed analysis and their recommendation was to move some programs (not ortho) from FMLH to FMF, similar to the process ortho has already gone through. In order to do that some FMF surgeries would need to be moved to the ASC's. Other options included expanding the ORs beyond the 10 hour blocks to 12 hours or longer, as well as adding an elective schedule on Saturday. Orthopaedics is planning on moving many of our outpatient total joints that are currently being done at FMF to Drexel ASC. This will allow for growth and backfill of other cases to FMF. The national trend is for surgeries to transition from inpatient to outpatient, particularly in orthopaedics. ASC's provide a lower cost environment as well as improved efficiencies. COVID-19 has likely accelerated this evolution in care delivery as the public's desire for inpatient stays has diminished. The F&MCW system currently has more than enough outpatient ASC space to accommodate growth. Lake Country ASC is currently shuttered and not operational and the utilization of the



existing ASC's other than FSC remains poor. Some of the newer outpatient centers have shelled in space that can accommodate additional OR's if needed.

Clinic space is an additional challenge that has been intensified by the COVID-19 crisis. Our department goal will likely be roughly 12-15% virtual visits moving forward which will decompress our clinics a bit. Currently with social distancing requirements the virtual visits are necessary to decrease in-person volumes and ensure a safe environment for our patients and staff. As we emerge from COVID-19 and resume more normal clinic volumes the decanting of some in-person visits to virtual will provide an opportunity for growth at Froedtert.

There are some critical "system" issues that impact our ability to grow and expand our clinic space. The definitive agreement between Froedtert and MCW prevents us from creating additional clinic space or an "Ortho Institute" independent of Froedtert. Because of this we are constrained to practice at Sports which was grandfathered into the definitive agreement, and at the Froedtert sites across the system. Unfortunately, the reimbursement for our work at the CP sites is lower than that with MCW rates on campus which is a disincentive to working at off-sites. I remain hopeful that the system will align and eliminate this differential moving forward. Ultimately MCW rates are likely to be unsustainable and new insurance contracts will likely decrease our reimbursement for more routine musculoskeletal care across the board. I am confident that as we expand and add providers the system will meet our needs for additional clinic space.

#### What has been the biggest challenge during COVID?

Without question, the biggest challenge for department leadership during COVID was the mandate by MCW to furlough members of the department. While I appreciate MCW was losing ~\$1,000,000 a day and needed to cut expenses, I would have preferred to manage the financial crisis in other ways and preserve the integrity of our teams. The people of this department are what make us special and allow us to do the incredible work that we do. Each and every one of us should feel valued and an integral part of our daily work. I feel fortunate that we were able to recover so quickly and bring most of our people back and make us whole again.

# **Q&A** with the Chairman

### What do you see as the biggest challenge for the new normal?

There will be many challenges, but I think one of the biggest challenges moving forward will be how we can avoid a similar situation. The COVID-19 crisis exposed tremendous supply chain flaws and perhaps more importantly, demonstrated how any increased demand that results in shortages can have a domino effect on the entire health care delivery system. Even now, we are running into critical shortages of ICU nurses and PPE that have far-reaching implications. The struggle will be to build redundancy into the system while restraining health care spending. We face these decisions every day as we try and figure out our workforce needs. What COVID-19 did is add instability and unpredictability into the equation which will be a tremendous hurdle moving forward.

### What opportunities (if any) do you see for the department in the current pandemic environment?

I believe in the potential and power of virtual care. As an academic, tertiary referral center, we are uniquely positioned to grow our practice in ways that were not possible before. Virtual appointments, the easier sharing of medical records through Care Everywhere, and the rapid transfer of imaging from one institution to another has facilitated second opinions and our ability to connect with patients who were previously unreachable to us due to distance. Virtual care provides us an opportunity to reach patients with less of a commitment on their part. Once they meet our exceptional providers and experience the unparalleled care they receive, it will allow us to grow and expand our reach, further establishing ourselves as the tertiary referral center of choice in the state.

### How do you see the recent COVID-19 pandemic impacting the way we work?

One of the biggest challenges we face moving forward is how we ensure the safety of the members of the department and continue to excel in clinical care, research, and education. The specter of closed daycare centers and schools places a tremendous additional burden on many. We will need to continue to evolve in our ability to work from home and ensure everyone has the appropriate resources to perform their job to the best of their ability in an evolving and uncertain environment. Individually we will need to find ways to balance potentially increasing demands on us from home, as well as work, as the far-reaching financial implications of the COVID-19 pandemic continue to put downward pressure on labor costs and hiring.

#### How do you see the recent COVID-19 pandemic impacting the way we provide patient care?

The genie is out of the bottle with regards to virtual care. Many of our patients will prefer the convenience and accessibility virtual visits offer. This will serve as a challenge as well as an opportunity. Identifying which patients can be evaluated virtually currently rests largely with the provider. I envision a future where the patient has more choices for care and will choose the most convenient visit for them. As the IT barriers resolve and the technological savvy of the population increases the percentage of patients who prefer an in-person "traditional" office visit will decline and we will find ourselves even more focused on patient convenience and connectivity to maintain and grow our practices.

## Have there been any positive insights you've gained with how things could change for the better going forward?

The COVID-19 crisis lit a fire under the administration of F&MCW. We were forced to make drastic decisions in a very short time. This sort of approach was not our typical modus operandi but it taught us many lessons on how to be a more dynamic and nimble organization. The next step is to figure out a way to be flexible and fast while ensuring more inclusive decision-making and buy-in from all. If we are able to negotiate that balance, it will benefit us all moving forward.




### **ASSH Annual Meeting Scholarship**
