Purpose: Update the Categories/Tasks available in the Effort Tracking Console to facilitate more streamlined entry for end user.

Notes: Deleted non-essential Categories and Tasks in order to make the decision-making process less confusing for the end user. For a full list of the remaining Categories/Tasks, see spreadsheet below (color coded by user type).

Time-Off and Administration can/should be used by ALL staff members, choosing the Effort Tracking protocol ONLY for these two Categories. NO OTHER CATEGORIES should use Effort Tracking as the protocol.

Regulatory, Lab and Finance Category/Tasks did NOT change.

CRCs/CRAs (including Nesha) use the Clinical Activity/Coordination Category, select the protocol and choose only between Protocol Related or Subject Related as tasks.
